

KINGDOM BUSINESS NETWORK INTERNATIONAL BUSINESS DIRECTORY AGREEMENT

This Agreement (“Agreement”) is entered into by and between:

Kingdom Business Network International LLC (“KBNI”), located at 4415 Nicole Drive, Suite G, Lanham, MD 20706, and the business entity registering for a listing in the Directory (the “Business”).

RECITALS:

WHEREAS, KBNI maintains an online business directory (the “Directory”) that promotes ethical and responsible business practices across various industries.

WHEREAS, the Business wishes to place a listing in the Directory to promote its services and products in alignment with KBNI’s core values of integrity, professionalism, and ethical business conduct.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein, the parties agree as follows:

1. Ethical Business Conduct

The Business agrees to adhere to the following ethical requirements as a condition of being listed in the Kingdom Business Network International Directory:

1.1 Honesty and Transparency

The Business shall provide accurate, honest, and truthful information regarding its services, products, business practices, and operations in its Directory listing and in any related communications. Misrepresentation, false advertising, or deceptive practices are strictly prohibited.

1.2 Compliance with Laws

The Business shall comply with all applicable local, national, and international laws, regulations, and standards governing its operations. This includes, but is not limited to, laws related to advertising, privacy, labor, health and safety, and environmental protection.

1.3 Respect for Human Rights

The Business shall operate in a manner that respects the fundamental rights and dignity of all individuals. This includes ensuring that no child labor, forced labor, or discriminatory practices are employed within its operations.

1.4 Conflict of Interest

The Business shall avoid conflicts of interest and disclose any situations in which its interests may conflict with those of KBNI. This includes refraining from any practices that may harm the integrity or reputation of KBNI or its members.

2. Accountability

2.1 Reporting of Violations

The Business agrees to promptly report any known violations of ethical conduct, including any misconduct within its operations or that of its affiliates, to KBNI. If any information in the Directory listing becomes outdated, inaccurate, or misleading, the Business agrees to communicate this to a KBNI representative via email, who will update it in a timely manner.

2.2 Suspension of Listing

KBNI reserves the right to suspend or remove the Business's listing from the Directory if the Business fails to comply with the ethical requirements outlined in this Agreement. Such suspension or removal shall be at KBNI's sole discretion, and no refund of any fees paid will be provided in the event of suspension or removal.

3. Indemnification and Liability

3.1 Indemnification

The Business agrees to indemnify and hold KBNI, its officers, employees, and affiliates harmless from any claims, damages, losses, liabilities, and expenses arising out of or in connection with any violation of this Agreement, including but not limited to any breach of the ethical conduct provisions or any legal action related to the Business's operations.

3.2 Limitation of Liability

KBNI shall not be liable for any direct, indirect, incidental, or consequential damages arising from the Business's use of the Directory, including any loss of business, goodwill, or reputation.

4. Term and Termination

4.1 Term

This Agreement shall commence on the date of signing and remain in effect for a period of one (1) year, unless terminated earlier in accordance with the provisions herein.

4.2 Termination for Breach

Either party may terminate this Agreement with immediate effect if the other party breaches any material term of this Agreement and fails to cure such breach within three (3) days after receiving written notice of the breach.

4.3 Voluntary Termination

The Business may voluntarily terminate this Agreement by providing five (5) days' written notice to KBNI. Upon termination, the Business's listing will be removed from the Directory. No refund of any fees paid will be provided in the event of termination.

5. Miscellaneous

5.1 Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Maryland.

5.2 Dispute Resolution

Any disputes arising under or in connection with this Agreement shall be resolved through binding arbitration in the State of Maryland, in accordance with the rules of the Maryland Arbitration Association.

5.3 Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, whether written or oral, relating to the subject matter hereof.
